## CONTRACT AGREEMENT

THIS AGREEMENT made this 26<sup>th</sup> day of April 2021 between **BULACAN AGRICULTURAL STATE COLLEGE** of Pinaod, San Ildefonso, Bulacan (hereinafter called the "Entity") and **CAIXIA CONSTRUCTION** of Brgy. Marawa, Jaen, Nueva Ecija (hereinafter called the "Supplier").

## NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
- The following documents shall be attached, deemed to form, and be read and construed as part of this Agreement, to wit:
  - (a) Prescribed supporting documents under the alternative mode of procurement (small value procurement)
  - (b) Other contract documents that may be required by existing laws and/or the Entity.
- 3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to wit:
  - (a) Execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.
  - Liquidated damages on the unperformed portion for every day of delay as required by the existing laws;
  - (c) The electricity and water consumption incurred while the projects are in progress.
- The Entity hereby covenants to pay the Supplier in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or

- such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
- 5. All applicable provisions and/or sections of the latest IRR of R.A. 9184 and latest GPPB Issuances pertaining to the procurement of goods/services shall be the guiding principles and procedures to be followed in this contract of agreement.
