# BAC RESOLUTION RECOMMENDING THE CANCELLATION OF THE BIDDING FOR THE ACQUISITION OF THE WEB-BASED COLLEGE CAMPUS MANAGEMENT SYSTEM

Name of Project: Acquisition of Web-Based College Campus Management System

ABC: P8,000,000.00

**WHEREAS**, the Bulacan Agricultural State College (BASC) intends to procure the above cited project with an approved budget of P8,000,000.00 which shall be undertaken through competitive bidding;

**WHEREAS**, on 22 October 2020, a pre-bid conference was held and attended by several prospective bidders, wherein clarifications were made by the prospective bidders as regards technical specifications of the project;

**WHEREAS**, on 27 October 2020, upon review by the Technical Working Group (TWG), the BAC deemed it necessary to issue Supplemental Bid Bulletin revising the technical specifications for the project as recommended by the TWG;

**WHEREAS**, on 5 November 2020, one prospective bidder submitted their bid documents before the deadline of the submission of bid documents on 9 November, 2020;

**WHEREAS**, on 6 November 2020, one prospective bidder purchased bid documents while another sent a clarificatory letter dated 5 November, 2020 as regards the supplemental bid bulletin 1 issued on 27 October, 2020, which was accepted accordingly and forwarded to the TWG for proper review and action;

**WHEREAS**, on the same day of 6 November 2020, to effect the review to be conducted by the TWG a postponement of the opening of bids scheduled on 9 November, 2020 was issued by the BAC;

**WHEREAS**, on 10 November 2020, upon review by the TWG, the TWG requested the BAC to terminate the on-going procurement of the above cited project to further study the revised terms of reference and technical specifications of the project;

**WHEREAS**, after due deliberation, the BAC deemed it necessary to refer the matter to the Head of the Procuring Entity (HoPE), the College President, for his consideration and appropriate action;

**WHEREAS**, Section 41.C, Reservation Clause of the Revised IRR of RA 9184 provides that the HoPE reserves the right to reject and all bids, declare a failure of bidding, or not award the contract for any justifiable and reasonable ground where the award of the contract will not redound to the benefit of the Government of the Philippines (GoP);

**WHEREAS**, in a memo dated 16 November 2020, the HoPE requested the BAC for the termination of the procurement of the aforementioned project to give ample time to the TWG for the review of the terms of reference and technical specifications of the project;

NOW, THEREFORE, we, the members of the BAC hereby RESOLVED as it is hereby RESOLVED to:
