
## **Contract Agreement**

THIS AGREEMENT, made this 15<sup>th</sup> day of April, 2021 between BULACAN AGRICULTURAL STATE COLLEGE, San Ildefonso, Bulacan (hereinafter called the "Entity") and AGILE TECHFRONTIER CORPORATION, LG-07 Peninsula Court Building, Paseo de Roxas Corner Makati Avenue, Brgy. Bel-Air, Makati City (hereinafter called the "Supplier").

WHEREAS, the Entity is desirous that the Supplier execute the Supply, Delivery, Assembly, and Installation of Photogrammetry, Remote Sensing, and GIS Equipment for the Provision of Higher Education under Contract No. 2021-01G (hereinafter called "the Works") and the Entity has accepted the Bid of nine hundred fifteen thousand one hundred forty-three pesos (Php915,143.00) by the Supplier for the execution and completion of such Works and the remedying of any defects therein and shall be completed within 90 calendar days.

## NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
- 2. The following documents shall be attached, deemed to form, and be read and construed as integral part of this Agreement, to wit:
  - (a) General and Special Conditions of Contract;
  - (b) Specifications;
  - (c) Invitation to Bid;
  - (d) Instructions to Bidders;
  - (e) Bid Data Sheet;
  - (f) Addenda and/or Supplemental/Bid Bulletins, if any;
  - Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
  - (h) Eligibility requirements, documents and/or statements;
  - (i) Performance Security;
  - (j) Notice of Award of Contract and the Bidder's conforme thereto;
  - (k) Other contract documents that may be required by existing laws and/or the Entity.







- In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity:
  - (a) Execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects; and
  - (b) Payment of liquidated damages on the unperformed portion for every day of delay as required by the existing laws.
- 4. The Entity hereby covenants to pay the Supplier in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
