

## Contract Agreement

THIS AGREEMENT, made this *15<sup>th</sup> day of April, 2021* between **BULACAN AGRICULTURAL STATE COLLEGE**, San Ildefonso, Bulacan (hereinafter called the "Entity") and **PRINCE TECHNOLOGIES CORPORATION**, Blk 2 Lot 17 Royal South Townhomes, Marcos Alvarez Avenue, Talon 5 Las Piñas City (hereinafter called the "Supplier").

WHEREAS, the Entity is desirous that the Supplier execute the supply, delivery, assembly and installation including training of Campus Management System under **Contract No. 2021-05G** (hereinafter called "the Works") and the Entity has accepted the Bid of seven million eight hundred thirty-six thousand eight hundred pesos (*Php7,836,800.00*) by the Supplier for the execution and completion of such Works and the remedying of any defects therein and shall be completed within 60 calendar days.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents shall be attached, deemed to form, and be read and construed as integral part of this Agreement, to wit:
  - (a) General and Special Conditions of Contract;
  - (b) Specifications;
  - (c) Invitation to Bid;
  - (d) Instructions to Bidders;
  - (e) Bid Data Sheet;
  - (f) Addenda and/or Supplemental/Bid Bulletins, if any;
  - (g) Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
  - (h) Eligibility requirements, documents and/or statements;
  - (i) Performance Security;
  - (j) Notice of Award of Contract and the Bidder's conforme thereto;
  - (k) Other contract documents that may be required by existing laws and/or the Entity.

3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity:
  - (a) Execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects; and
  - (b) Payment of liquidated damages on the unperformed portion for every day of delay as required by the existing laws.
4. The Entity hereby covenants to pay the Supplier in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
