

Contract Agreement

THIS AGREEMENT made this 19th day of *April 2021* between **BULACAN AGRICULTURAL STATE COLLEGE**, San Ildefonso, Bulacan (hereinafter called the "Entity") and **SHENDAR INTERNATIONAL CERTIFICATIONS MANAGEMENT CONSULTANCY SERVICES**, Lambunao, Iloilo, Region VI (hereinafter called the "Consultant").

WHEREAS, the Entity is desirous that the Consultant executes the *Consulting Services and Certification Facilitation on Quality Management System ISO 9001-2015* (hereinafter called "the Works") and the Entity has accepted the proposal/bid for the sum of Eight Hundred Thousand Pesos (**PHP800,000.00**), inclusive of all applicable government taxes and charges, professional fees, and other incidental and administrative costs, by the Consultant for the execution and completion of such Consulting Services and the remedying of any defects therein and shall be completed within six (6) months from the receipt of the Notice to Proceed.

NOW, THIS AGREEMENT WITNESSETH AS FOLLOWS:


1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents shall be attached, deemed to form, and be read and construed as an integral part of this Agreement, to wit:
 - (a) General and Special Conditions of Contract;
 - (b) Term of reference;
 - (c) Specifications;
 - (d) Invitation to Bid;
 - (e) Instructions to Proponents/Bidders;
 - (f) Proposal/Bid Data Sheet;
 - (g) Addenda and/or Supplemental/Bid Bulletins, if any;
 - (h) Proposal/Bid forms, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., proponent's/bidder's response to a request for clarifications on the proposal/bid), including corrections to the proposal/bid, if any, resulting from the Procuring Entity's proposal/bid evaluation;
 - (i) Eligibility requirements, documents, and/or statements;
 - (j) Performance Securing Declaration;


- (k) Notice of Award of Contract and the Proponent's/Bidder's conforme thereto;
 - (l) Other contract documents that may be required by existing laws and/or the Entity including minutes of contract negotiations.
3. The Entity hereby covenants the Consultant to pay liquidated damages for the failure to deliver/perform said services with the applicable governing laws of this Contract.
 4. In consideration of the payments to be made by the Entity to the Consultant, the Consultant hereby covenants with the Entity to deliver said services in conformity with the provisions of this Contract in all respects.
 5. The Entity hereby covenants to pay the Consultant in consideration of the delivery of said services, the Contract Price, or such other sum as may become payable at the time and in the manner prescribed by this Contract.


