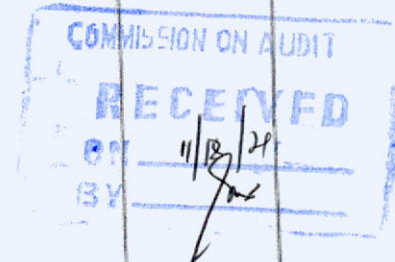

## Omnibus Sworn Statement

### AFFIDAVIT

I, **Rhee Carla Ong Acantilado**, of legal age, married, Filipino, and residing at Block 7 Lot 27 Greenpark Villas Phase 1, Malagasang 2-D, Imus, Cavite, after having been duly sworn in accordance with law, do hereby depose and state that:

1. I am the sole proprietor or authorized representative of **Kayac Book Trading** with office address at Sitio Bulbok, Castanos Lejos, Gen. E. Aguinaldo, Cavite;
2. As the owner and sole proprietor, or authorized representative of **Kayac Book Trading**, I have full power and authority to do, execute and perform any and all acts necessary to participate, submit the bid, and to sign and execute the ensuing contract for **Subscription of Journals and Magazines** of the **Bulacan Agricultural State College**, as shown in the attached duly notarized Special Power of Attorney;

The owner or sole proprietor is not related to the Head of the Procuring Entity, members of the Bids and Awards Committee (BAC), the Technical Working Group, and the BAC Secretariat, the head of the Project Management Office or the end-user unit, and the project consultants by consanguinity or affinity up to the third civil degree;
7. **Kayac Book Trading** complies with existing labor laws and standards; and
8. **Kayac Book Trading** is aware of and has undertaken the responsibilities as a Bidder in compliance with the Philippine Bidding Documents, which includes:
  - a. Carefully examining all of the Bidding Documents;
  - b. Acknowledging all conditions, local or otherwise, affecting the implementation of the Contract;
  - c. Making an estimate of the facilities available and needed for the contract to be bid, if any; and
  - d. Inquiring or securing Supplemental/Bid Bulletin(s) issued for the **Subscription of Journals and Magazines**.
9. **Kayac Book Trading** did not give or pay directly or indirectly, any commission, amount, fee, or any form of consideration, pecuniary or otherwise, to any person or official, personnel or representative of the government in relation to any procurement project or activity.

In case advance payment was made or given, failure to perform or deliver any of the obligations and undertakings in the contract shall be sufficient grounds to constitute criminal liability for Swindling (Estafa) or the commission of fraud with unfaithfulness or abuse of confidence through misappropriating or converting any payment received by a person or entity under an obligation involving the duty to deliver certain goods or services, to the prejudice of the public and the government of the Philippines pursuant to Article 315 of Act No. 3815 s. 1930, as amended, or the Revised Penal Code.


