### 3.0 Exclusions

**Sub-clause 8.3, Design and Development of Products and Services** is not applicable to the Quality Management System of Bulacan Agricultural State College (BASC). Its mandate, as defined in **RA 8548**, is to provide services on tertiary program and advanced education offerings based on the existing and emerging needs of the clients. The program, standards, and guidelines of all curricular programs regarded as core services or products of the college are all duly prescribed by the Commission on Higher Education (CHED). These programs are implemented through CHED Memorandum Orders where all Higher Education Institutions (HEIs) in the Philippines including the **Bulacan Agricultural State College** are mandated to comply with.

In addition, the Commission on Higher Education (CHED) issued a **Certificate of Program Compliance (COPC)** for programs that meets the minimum requirements set in the standards; otherwise, it has to be recommended for gradual phased out. Hence, the organization has apparently no means to design and develop its own service or product but rather dependent only on the predesigned and predeveloped products and services from CHED.
