

Contract Agreement

THIS AGREEMENT made this 9th day of *November 2021* between **BULACAN AGRICULTURAL STATE COLLEGE**, San Ildefonso, Bulacan (hereinafter called the "Entity") and **BUREAU VERITAS SA**, 8th Floor, Ramon Magsaysay Center, 1680 Roxas Blvd. cor. Quintos Street Ermita, Manila (hereinafter called the "Consultant").

WHEREAS, the Entity is desirous that the Consultant executes the *Procurement Service for the ISO Certification* (hereinafter called "the Works") and the Entity has accepted the proposal/bid for the sum of Thee Hundred Thousand One Hundred Sixty Pesos (*PhP300,160.00*), inclusive of all applicable government taxes and charges, professional fees, and other incidental and administrative costs, by the Consultant for the execution and completion of such Consulting Services and the remedying of any defects therein and shall be completed within three (3) years from the receipt of the Notice to Proceed.

NOW, THIS AGREEMENT WITNESSETH AS FOLLOWS:


1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents shall be attached, deemed to form, and be read and construed as an integral part of this Agreement, to wit:
 - (a) General and Special Conditions of Contract;
 - (b) Term of reference;
 - (c) Request for Expression of Interest
 - (d) Instructions to Proponents/Bidders;
 - (e) Proposal/Bid Data Sheet;
 - (f) Addenda and/or Supplemental/Bid Bulletins, if any;
 - (g) Proposal/Bid forms, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., proponent's/bidder's response to a request for clarifications on the proposal/bid), including corrections to the proposal/bid, if any, resulting from the Procuring Entity's proposal/bid evaluation;
 - (h) Eligibility requirements, documents, and/or statements;
 - (i) Performance Securing Declaration;
 - (j) Notice of Award of Contract and the Proponent's/Bidder's conforme thereto;
 - (k) Other contract documents that may be required by existing laws and/or the Entity include minutes of contract negotiations.


3. The Entity hereby covenants the Consultant to pay liquidated damages for the failure to deliver/perform said services with the applicable governing laws of this Contract.
4. In consideration of the payments to be made by the Entity to the Consultant as hereinafter mentioned, the Consultant hereby covenants with the Entity to execute and complete the Consulting Services and remedy any defects therein in conformity with the provisions of this Contract in all respects.
5. The Entity hereby covenants to pay the Consultant in consideration of the execution and completion of the Consulting Services, the Contract Price, or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
