## **Contract Agreement**

  - (h) Eligibility requirements, documents, and/or statements;
  - (i) Performance Securing Declaration;
  - Notice of Award of Contract and the Proponent's/Bidder's conforme thereto;
  - (k) Other contract documents that may be required by existing laws and/or the Entity include minutes of contract negotiations.
