

Contract Agreement

THIS AGREEMENT made this 10th day of *June 2022* between **BULACAN AGRICULTURAL STATE COLLEGE**, San Ildefonso, Bulacan (hereinafter called the "Entity") and **PRINCE TECHNOLOGIES CORPORATION**, Block 2 Lot 17 Royal South Townhomes Marcos Alvarez Avenue, Talon 5 Las Piñas City (hereinafter called the "Supplier").

WHEREAS, the Entity is desirous that the Supplier executes the *Procurement for the Acquisition of Service Maintenance and Cloud Service Subscription for the BASC Campus Management System* (hereinafter called "the Works") and the Entity has accepted the quotation/proposal for the sum of Four Million Two Hundred Seventy-five Thousand Four Hundred Forty-three Pesos and Twenty Centavos (**PhP4,275,443.20**) by the Supplier for the execution and completion of such Works and the remedying of any defects therein.

NOW, THIS AGREEMENT WITNESSETH AS FOLLOWS:


1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents shall be attached, deemed to form, and be read and construed as an integral part of this Agreement, to wit:
 - (a) Software Maintenance Agreement with bundled AWS Cloud Service;
 - (b) Canvass Form/Quotation;
 - (c) Eligibility requirements, documents, and/or statements, PhilGEPS Certificate of Registration, Business Registration, Mayor's Permit, and Tax Clearance;
 - (d) Performance Security;
 - (e) Notice of Award of Contract and the Proponent's/Bidder's conforme thereto;
 - (f) Other contract documents that may be required by existing laws and/or the Entity include minutes of contract negotiations.
3. The Entity hereby covenants the Supplier to pay liquidated damages for the failure to deliver/perform said services with the applicable governing laws of this Contract.
4. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to execute and complete "the Works" and remedy any defects therein in conformity with the provisions of this Contract in all respects.
5. The Entity hereby covenants to pay the Supplier in consideration of the execution and completion of the "the Works", the Contract Price, or such other




sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.


