 - (a) Prescribed supporting documents under alternative mode of procurement (small value procurement)
 - (b) Other contract documents that may be required by existing laws and/or the Entity.
- In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to wit:
 - (a) Execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.
 - (b) Liquidated damages on the unperformed portion for every day of delay as required by the existing laws;
 - (c) The electricity and water consumption incurred while the projects are in progress.
- The Entity hereby covenants to pay the Supplier in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or

such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.

All applicable provisions and/or sections of the latest IRR of R.A. 9184 and latest GPPB
Issuances pertaining to the procurement of goods/services shall be the guiding
principles and procedures to be followed in this contract of agreement.
