

## Contract Agreement

THIS AGREEMENT made this 15<sup>th</sup> day of *December 2022* between **BULACAN AGRICULTURAL STATE COLLEGE**, San Idefonso, Bulacan (hereinafter called the "Entity") and **TRI-ACCESS VETERINARY TRADING CORPORATION**, 032 San Carlos Drive, Mataas na Lupa, Lipa City, Batangas (hereinafter called the "Supplier").

WHEREAS, the Entity is desirous that the Supplier executes the *supply, delivery, shipment, and transport of Swine Breeder* under *Contract No. 02 Goods-2022* (hereinafter called "the Works") and the Entity has accepted the bid for one million one hundred seventy-six thousand four hundred seventy pesos and thirty-four centavos (*Php1,176,470.34*) by the Supplier for the execution and completion of such Works and the remedying of any defects therein and shall be completed within thirty (30) calendar days.

NOW, THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents shall be attached, deemed to form, and be read and construed as an integral part of this Agreement, to wit:
  - (a) General and Special Conditions of Contract;
  - (b) Specifications;
  - (c) Invitation to Bid;
  - (d) Instructions to Bidders;
  - (e) Bid Data Sheet;
  - (f) Addenda and/or Supplemental/Bid Bulletins, if any;
  - (g) Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to a request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
  - (h) Eligibility requirements, documents, and/or statements;
  - (i) Performance Security;
  - (j) Notice of Award of Contract and the Bidder's conforme thereto;
  - (k) Other contract documents that may be required by existing laws and/or the Entity.
3. The Entity hereby covenants the Supplier to pay liquidated damages for the failure to deliver/perform said services with the applicable governing laws of this contract.





IN WITNESS whereof the parties thereto have caused this Agreement to be executed the day and year first before written.






