

Contract Agreement

THIS AGREEMENT made this 6th day of *January 2023* between **BULACAN AGRICULTURAL STATE COLLEGE**, San Ildefonso, Bulacan (hereinafter called the "Entity") and **PHILIPPINE LONG DISTANCE TELEPHONE, INC.**, Ramon Cojuangco Building Makati Avenue, Makati City (hereinafter called the "Supplier").

WHEREAS, the Entity is desirous that the Supplier executes the *Procurement for the BASC Fiber Backbone Upgrade for the Learning Management System Implementation* (hereinafter called "the Works") and the Entity has accepted the quotation/proposal for the sum three million seven hundred fifty thousand pesos (*Php3,750,000.00*) *vat exclusive* by the Supplier for the execution and completion of such Works and the remedying of any defects therein.

NOW, THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents shall be attached, deemed to form, and be read and construed as an integral part of this Agreement, to wit:
 - (a) Terms and Conditions;
 - (b) Canvass Form/Quotation;
 - (c) Eligibility requirements, documents, and/or statements, PhilGEPS Certificate of Registration, Business Registration, Mayor's Permit and Tax Clearance;
 - (d) Performance Security;
 - (e) Notice of Award of Contract and the Proponent's/Bidder's conforme thereto;
 - (f) Other contract documents that may be required by existing laws and/or the Entity.
3. The Entity hereby covenants the Supplier to pay liquidated damages for the failure to deliver/perform said services with the applicable governing laws of this contract.
4. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.
5. The Entity hereby covenants to pay the Supplier in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the



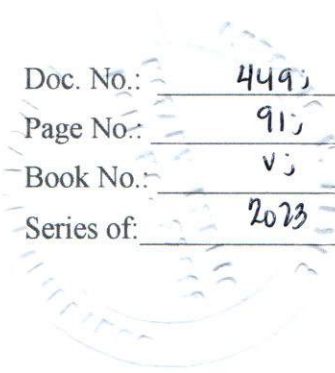
