

CONTRACT AGREEMENT

THIS AGREEMENT made this 18th day of May 2023 between **BULACAN AGRICULTURAL STATE COLLEGE** of Pinaod, San Ildefonso, Bulacan (hereinafter called the "Entity") and **PRINCE TECHNOLOGIES CORPORATION** Block 2 Lot 17 Royal South Townhomes, Marcos Alvarez Avenue, Talon 5 Las Piñas City (hereinafter called the "Supplier").

WHEREAS, the Entity is desirous that the Supplier execute the **Procurement for the Service Maintenance and Cloud Service Subscription for the BASC Campus Management System** (hereinafter called "the Works") and the Entity has accepted the quotation/proposal for the sum of Four Million Six Hundred Thirty-five Thousand Four Hundred Forty-three Pesos and Twenty Centavos (**Php4,635,443.20**) by the Supplier for the execution and completion of such works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents shall be attached, deemed to form, and be read and construed as part of this Agreement, to wit:
 - (a) Software Maintenance Agreement with bundled AWS Cloud Service
 - (b) Canvass Form/Quotation
 - (c) Eligibility requirements, documents, and/or statements, PhilGEPS Certificate of Registration, Business Registration, Mayor's Permit, and Tax Clearance;
 - (d) Performance Security;
 - (e) Notice of Award of Contract and the Proponent's/Bidder's conforme thereto;
 - (f) Other contract documents that may be required by existing laws and/or the Entity include minutes of contract negotiations.
3. The Entity hereby covenants the Supplier to pay liquidated damages for the failure to deliver/perform said services with the applicable governing laws of this Contract.
4. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to execute and complete "the






