


WHEREAS, the Entity invited Bids for certain works, particularly for the **Supply and Delivery of Electrical Supplies with Labor and Installation for the Application of Meter with Transformer and Upgrading of Load Side Wire in DRT Campus.**

WHEREAS, the Contractor submitted a responsive bid and was awarded the contract for the procurement in the total amount of **One Million Two Hundred Ninety Eight Thousand Forty Pesos Only (Php1,298,040.00)**, hereinafter referred to as the "Contract Price."


NOW, THEREFORE, for and in consideration of the foregoing premises, the parties hereby agree as follows:

1. Unless otherwise stated, terms and expressions used in this Contract shall have the same meanings as those assigned to them in the Conditions of Contract, which form an integral part of this Contract.
2. The following documents as required by the Implementing Rules and Regulations of Republic Act No. 12009 shall form part and be read and construed as integral parts of this Contract, *viz.:*
 - i. Drawings/Plans;
 - ii. Scope of Work;
 - iii. Invitation to Bid;
 - iv. Bid Form,
 - v. Bill of Quantities;
 - vi. Other contract documents that may be required by existing laws and/or the Entity;
 - vii. Performance Securing Declaration;
 - viii. Notice of Award of Contract;
 - ix. and the Bidder's Conforme thereto; and
 - x. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBD, such as but not limited to the Notice to Proceed and Warranty Security.
3. In consideration of the Contract Price of **One Million Two Hundred Ninety Eight Thousand Forty Pesos Only (Php1,298,040.00)**, or such other sums as may be determined in accordance with the terms of the Contract, the Contractor agrees to deliver and perform the items and related services for the **Supply and Delivery of Electrical Supplies with Labor and Installation for the Application of Meter with Transformer and Upgrading of Load Side Wire in DRT Campus.** described herein in accordance with the terms and conditions specified in the Contract and its annexed documents.
4. The **Bulacan Agricultural State College** agrees to pay the above-mentioned sum to the Contractor in accordance with the schedule and manner provided in the Bidding Documents and its annexes.
